1. Students who receive a final grade of an “NC” are eligible to enroll in the competency recovery program. Students are able to recover up to TWO competencies per course, but not exceeding 50% of competencies.
2. All students will meet with the recovery teacher to create a recovery plan. Students and teachers will meet daily during the assigned week to complete the recovery plan. Additional time can be arranged, and students are expected to attend the program on assigned days. (See attendance policy below).
3. Students should speak with their guidance counselor for forms and information. All registration forms and money will be due by June 30th . Check is made payable to the NSD Competency Program.

**ATTENDANCE POLICY:** Attendance at all sessions is expected until the teacher dismisses students for completion of all work. No refunds will be available once the sessions start. Attendance is **not a guarantee** of successful completion. **Students' work must demonstrate competency to receive credit.**
