Dear Parents and/or Guardians,

This form explains the provisions under Federal Law (No Child Left Behind) as related to release of information to the military. If you do not wish your “directory information”, as noted, to be released please sign and return the bottom of this form to the school’s main office. Note: this is different from, and in addition to, the school district waiver for release of information to the news media, etc. Once signed, we will consider this restriction to be in place for your child’s full career at Nashua High School South unless you rescind this form at a later date.

**DO NOT RELEASE INFORMATION TO MILITARY RECRUITERS 2008-2009**

Section 9528 of NCLB allows military recruiters access to high school campuses, venues to interact with students and parents, as well as student directory information.

**ACCESS TO STUDENT RECRUITING**

1. **INFORMATION** – Notwithstanding section 444(a)(5)(B) of the General Provisions Act and except as provided in paragraph (2), each local education agency receiving assistance under this Act shall provide, on a request made by the military recruiters access to secondary school student names, addresses and telephone listings.
2. **CONSENT** - A secondary school student or the parent of the student may request that the student’s name, address and telephone listing described in paragraph (1) not be released without written parental consent and the local education agency or private school shall notify parents of the option to make a request and shall comply with any request.
3. **SAME ACCESS TO STUDENTS** – Each local educational agency receiving assistance under this Act shall provide military recruiters the same access to secondary school students as is provided generally to post secondary educational institutions or to prospective employers of those students.

Student Directory Information consists of the following: Student Name, Student Address, Student Phone Number, Junior or Senior Class status. This provision does not conflict with FERPA (Family Educational Rights and Privacy Act).

I have read the foregoing and understand its terms and stipulations and by my signing this document, I hereby direct NHS South not to release any student directory information to any military/armed forces organization under the provisions of Section 9528 of the “No Child Left Behind Act”.
