# **POLICIES AND PROCEDURES**

## **Attendance**

### ATTENDANCE IS MANDATORY – Automatic failure after 2 absences. THREE (3) TARDIES EQUALS 1 ABSENCE.

#### **Policies**

All policies are in accordance with Nashua High School discipline code and the Nashua School District. No smoking will be allowed at Nashua High School (within the building or on the grounds) in accordance with state law. No hats or other head covering is permitted. Violations will result in suspension from class and a charged an absence. Any behavior that impedes the operation of the Nashua Adult & Community School or negatively impacts a class will result in a student's removal from the course and/or the school.

#### **Payment and Refunds**

Students can submit a check or money order made payable to the Nashua School District. Payment is required on the first day of class. There will be a \$25 processing fee charged for any returned checks. Refunds are granted in full if course is cancelled or requested before the second class meeting.

#### Food and Beverages

Bottled water is permitted in classrooms. **NO OTHER** food or beverage is allowed in the classrooms or in the hallways. All snacks/drinks must be consumed in the cafeteria.

#### **Building Usage Restrictions**

Use front doors **only** for entrance/exit. Use front parking lot (closest area)

#### **Course Materials and School Property**

All books, unless paid for by individual students, are the property of Nashua High School. Failure to return any book at the end of the course will result in a charge for the replacement costs of the text. Grades will be withheld until all materials are returned or until all charges are paid. Also, if any piece of equipment is broken and/or if the facility itself is damaged, the student will pay any repair/replacement costs. Again, grades will be withheld until all charges are paid.
