COMPETENCY ASSESSMENT REGULATIONS AND PROCEDURES

To earn a credit for a given course, a student must meet all course requirements including earning a course competency score of C- or better in all course competencies. Courses will have multiple competencies identified in each course. The Assistant Superintendent for Curriculum and Instruction or designee will have final approval of course competencies.

Students will have multiple opportunities to demonstrate their understanding of each required course competency during a course.

A student's grade on a competency will be included as a portion of the student's final course grade.

If a student receives a score of C- or better in all course competencies, the scores will be averaged together to determine a final grade.

If a student receives a C- or higher in at least half of their course competencies, they are eligible for post-course recovery and will be able to recover their course competencies to a score of C-.

If a student does NOT receive a score of C- or higher in at least half of their course competencies, no credit will be earned.

Grading Scale

The grading scale will be used in three distinctive ways: 1) to report out scores on assignments 2) to provide a grade for each course competency, and 3) to provide an overall end of course grade when the class experience ends.
